STATE ARTS COUNCIL AWARDS \$312,800 IN STIMULUS GRANTS FOR JOB PRESERVATION IN ALABAMA

Montgomery, Ala. -- As a part of the American Recovery and Reinvestment Act (ARRA), the Alabama State Council on the Arts (ASCA) awarded \$312,800 in Stimulus Grants for job preservation at its meeting in Alexander City on September 11, 2009. To be eligible for the program, applicants needed to comply with very specific guideline requirements. ARRA provided \$50 million to be distributed in direct grants to fund arts projects and activities, which preserve jobs in the nonprofit arts sector, threatened by declines in philanthropic and other support during the current economic downturn. Forty percent of such funds are being distributed through state arts agencies and regional arts organizations. As partners of the NEA, the state arts agencies (SAAs) and regional arts organizations (RAOs) are playing an important role in advancing the goals of this program. The NEA has awarded funds to the SAAs and RAOs specifically for projects that focus on the preservation of jobs in the arts.

These ARRA or stimulus grants are in response to applications submitted under a July 10, 2009 deadline and represent the crucial need for job preservation in arts organizations in Alabama. The Council received 53 applications requesting over \$1.5 million dollars. The review process was very competitive and a real challenge for the Council.

“The Council is very pleased with these special and needed monies from the NEA. These funds will be directly reinvested in Alabama’s arts organizations,” said Ralph Frohsin, Chair of the Council. Frohsin further added, ***“One of the Council’s main priorities has always been to help sustain Alabama’s arts and cultural organizations. These stimulus grants will be used where they are needed most — for job preservation in the arts at this critical point in time.”***

The Alabama State Council on the Arts awarded twelve stimulus grants to arts organizations in Alabama as follows:

The Alabama State Council on the Arts is the official state arts agency of Alabama. The staff of the Council, directed by Al Head, administers the grants programs and provides technical assistance in arts planning and programming. The 15-member Council is chaired by Ralph Frohsin of Alexander City. Board members are appointed for 6-year terms by the Governor to help promote the arts statewide. A primary responsibility of the Council is to make decisions on grants awarded to support art programs and arts education throughout the state. Board members are selected from all regions of the state in order to strive for a geographic spread representing all areas of the state. The Council receives its support through an annual appropriation from the Alabama Legislature and funding from the National Endowment for the Arts, a federal agency.

The National Endowment for the arts (NEA) awarded nine grants directly to arts organizations in Alabama including:
